REACH registration for co-registrants (joint submissioners):

Co-registrants /members of a joint submission who intend to register one of the above-mentioned substances under Regulation (EC) 1907/2006 (REACH) can now go on and submit their joint-submission dossier to ECHA. If your company is a SIEF-member but not a member of the Sulfur dioxide based chemicals REACH Consortium, you will need to go ahead with the following steps:

- Purchase a Letter of Access (LoA) to the technical dossier from SDIOC utilising the details given in "[LOA](#)".

- Join the Joint Submission for the desired substance in REACH-IT. The joining details will be submitted after LoA purchase.
